WHEREAS, the DOST- MIMAROPA advertised the Invitation to Bid for "Supply, Delivery, Fabrication, and Installation of Various Equipment for New Green Mussel Based Food Product Development" with an approved budget of the contract (ABC) of *One Million Eight Hundred Twenty-Eight Thousand Four Hundred Thirty-Eight Pesos and Eighty Centavos* (PhP 1,828,438.80) in the DOST-MIMAROPA website, the PHILGEPS and in conspicuous places at the premises of the DOST;

WHEREAS, in response to the said advertisement, ten (10) prospective bidders, purchased the bid documents for the said procurement project, and submitted eligibility documents for bidding and eight (8) were rated passed in the preliminary examination of bid;

WHEREAS, upon opening of the 2nd envelope (financial bid), **four (4) bidders** were identified as the Lowest Calculated Bidders;


