



Supply, Delivery and Installation of SPRAY-DRYING Facility for the Calamansi Farmers in Oriental Mindoro

The Department of Science and Technology – MIMAROPA (DOST-MIMAROPA), through its Bids and Awards Committee (BAC) invites all prospective bidders to bid for the project **“Supply, Delivery and Installation of SPRAY-DRYING Facility for the Calamansi Farmers in Oriental Mindoro”** in the amount of **Two Million Nine Hundred Seventy Thousand Pesos Only (PhP2,970,000.00)** being the Approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. DOST-MIMAROPA now invites sealed bids for **Supply, Delivery and Installation of SPRAY-DRYING Facility for the Calamansi Farmers in Oriental Mindoro**

3. Delivery of the Goods is required within **90 days** from the issuance of NOTICE TO PROCEED. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
5. Interested bidders may obtain further information from DOST-MIMAROPA and inspect the Bidding Documents at the address given below from 9:00 AM to 5:00 PM.

A complete set of Bidding Documents may be purchased by interested Bidders on **July 21 – August 14, 2018** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Two Thousand Nine Hundred Seventy Pesos Only (PhP 2,970.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the



Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. DOST-MIMAROPA will hold a **Pre-Bid Conference on July 31, 2018, 10:00 AM at DOST-MIMAROPA Conference Room, 4/F DOST-PTRI Building, General Santos Avenue, Bicutan, Taguig City** which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **August 14, 2018, 11:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause **Error! Reference source not found.**

Bid opening shall be on **August 14, 2018, 1:00 PM DOST-MIMAROPA Conference Room, 4/F DOST-PTRI Building, General Santos Avenue, Bicutan, Taguig City**. Bids will be opened in the presence of the Bidders' representative(s) who choose to attend at the address given. **Late bids shall not be accepted.** Official Time is the **Philippine Standard Time**.
